

#### THE CAPEC JSC HAS RENEWED THE COMPOSITION OF THEIR SHAREHOLDERS

The Central-Asian Power Energy Company (CAPEC JSC) has renewed the list of their shareholders: the major participants of the Company are Alexander Klebanov and Sergey Kan.

In July-August of the current year, the Major Shareholders of CAPEC JSC, Alexander Klebanov and Sergey Kan, increased their shares in the Company by buying out a share from Yerkyn Amirkhanov who held 30,9993% of shares of CAPEC JSC, and other shareholders. Currently, the Major Shareholders of CAPEC JSC, who hold

equal shares, are Alexander Klebanov and Sergey Kan.

On August 13, 2018, the CAPEC JSC's Board of Directors decided to alienate 23,8330% of shares of Eximbank Kazakhstan JSC. A transaction on the sale of the said shares from CAPEC JSC to Yerkyn Amirkhanov and his affiliated

companies was conducted at the United Security Registrar JSC on August 25, 2018. As a result of the conducted transactions, Eximbank Kazakhstan JSC is no longer part of the CAPEC JSC Group of Companies. In this regard, on August 25, 2018, Alexander Klebanov who was the Chairman of the Board of Directors, and the Members of the Board of Directors -Sergey Kan and Valeria Kim, withdrew from the Eximbank Kazakhstan JSC's Board of Directors on their own initiative.

On September 26, 2018, with a view to collect information according to the Indicator "Connection to the power supply system" of the Subnational Rating "Doing Business", the North Kazakhstan Regional Electric Distribution Company JSC was visited by international experts from the World Bank. The meeting was also attended by the heads of the State Institution "Territorial Department of the Committee for Atomic and Energy Supervision and Control of the RK Ministry of Energy for the North Kazakhstan Region and the State Institution "Department of Energy and Housing and Public Utilities" of the North Kazakhstan Akimat.

Following the results of the meeting, experts noted the following positive points on the organization of work and the improvement of the customer service quality:

 operation of the consumer service centre designed to face-to-face reception of consumer requests concerning energy consumption, tech-

nological connections, effecting payments, creating a comfortable and ergonomic interaction environment, and improving the service efficiency;

• implementation of an automated process control system for technological connections of consumers;

• availability of an electronic capacity map on the Company's website that displays information on the available capacities at substations of the North-Kazakhstan Regional Electric Distribution Company JSC;



• compliance of the Company to the International Standards ISO 9001, ISO 14001, and OHSAS 18001 confirmed by the presence of international certificates. At the final meeting, prospects for the implementation of a WEB-portal for receiving requests and issuing technical specifications were announced, and the said portal will allow consumers to apply for technical specifications online, and to track applications and receive ready-made technical specifications. hope that subsequent mutual audits will also help us in improving our processes. On behalf of the HSE Department of CAEPCO JSC, we express our gratitude to the HSE Team of SEVKAZENERGO JSC, and also to the Public Relations Department for assistance in organizing the mutual audit" - said Ruslan Zinatulin, the Director of the HSE Department.

# THE 2018-2019 HEATING SEASON HAS STARTED

The heating season has been started in the northern regions: since September of 12 in Petropavlovsk, since September of 14 in Ekibastuz and since September of 17 in Pavlodar.

For power engineers, this is a kind of the intermediate result of the preparatory work carried out at combined heat and power plants and heat supply networks.

During the summer period, tens of projects for reconstruction and modernization were implemented in Pavlodar, Ekibastuz and Petropavlovsk. Prior to the beginning of the heating season in the regions, press tours were held, organized jointly with the Department of the Committee for Natural Monopoly Regulation of each region. Power engineers familiarized representatives of state authorities and mass media with implemented projects at facilities.

This year, in the summer, a special emphasis was placed on public awareness efforts with Apartment Owners Cooperatives and apartment owners in relation to the importance of preparing for the new season. That, of course, drew the attention of residents to the problems with a readiness passport heat engineers annually face in the first month of connection to heat supply.

Sevkazenergosbyt LLP will soon plan to launch a mobile version of the Personal Account Service, and in future a mobile application in Google Play/App Store.

2870 domestic consumers and 2450 legal entities are connected to the Personal Account Service on the website of SEVKAZENERGO JSC.

On the website, a consumer can, on his own and at a time which suits him, find information on his debts and charges/ accruals, and generate and print out an invoice and make payment without waiting for the controller.

In addition, in the Personal Account, the city residents can enter their meter readings for electricity and DHW, and make payment without leaving home.

Thanks to the interactive service, a consumer can leave a request to the Company on any issues of power supply. All requests are received by the management for the purposes of control in automatic mode.

The same features will be available in the mobile application.

## AEDC JSC'S INTEGRATED MANAGEMENT SYSTEM

In AEDC JSC, the Integrated Management System (IMS) for Quality, Ecology and Occupational Safety and Health has been implemented and certified.

With a view to reduce the negative environmental impact while simultaneously increasing production volumes, reducing unit costs of raw and other materials, saving energy resources, and improving the quality of the services performed, AEDC JSC has taken a decision on the implement the IMS that meets the requirements of the International Standards ISO 9001, ISO 14001 and OHSAS 18001.

The IMS was implemented in the Company successively performing interrelated steps including the organization of work on its establishment, design, documentation, implementation and certification.

Methodical and consulting services in the implementation of international standards for management systems were rendered by the Quality Management Experts LLP. In the first half of 2018, the implementation of the international standards of the ISO and OHSAS Series was completed. The necessary documented procedures were developed and implemented as required by the international standards. The company adopted a policy for quality, ecology, occupational safety and health.

In May of 2018, a certification audit was successfully completed. Based on the results, TÜV Rheinland Group issued Compliance Certificates as per ISO 9001: 2015 "Quality Management Systems", ISO 14001: 2015 "Environmental Management Systems", and OHSAS 18001: 2007 "Occupational Safety and Health Management Systems".



In 2015, the PROFENERGY program was launched by the CAEPCO JSC's subsidiaries for the system of supporting young professionals and attracting graduates to enterprises. As part of PROFENERGY, there are projects aimed at developing and improving the educational level of the personnel, and retaining key employees. The program aims at promoting the state policy for training technical personnel.
