Managers of Sevkazenergosbyt LLP carried out 86 consultations of consumers regarding personal matters. General Director carries out consultation regarding personal matters in Petropavlovsk once a week. For the purpose of improving quality and operability of consumer services in Petropavlovsk on the basis of Service Center of Sevkazenergosbyt LLP, the company's Call Center operates at the address: 66 Zhurnabayev Street. Call Center allows consumers to give the readings of electric power meters and hot water supply meters every day from 08:00 till 20:00, receive the comprehensive information regarding the calculation carried out, current indebtedness, execution of documentation, reception of readings, and regarding the matters of planned and emergency power outage, on multi-line phone number: 500-666. Interactive Voice Response System provides information on standard questions in automatic mode. Total the Call Center receives about 21 000 calls a month. On average in working days the operators receive about 930 calls, the maximum quantity of received calls reaches 2500 a day. Another innovation in operation of power supply company is opening of a tag "My Account" at the official website of SKE JSC. This option allows consumers to make many operations staying at home. For the end of 2015, the interactive service "My Account" is used by 1981 consumers of Petropavlovsk and North-Kazakhstan region, including 838 household consumers of the city and regional districts. Besides, on the company's website the consumers have an access to information on tariffs, regulatory and legal base, information on consumer service centers, payment receiving centers, planned power outages.
